IV. Staff Items:

A. Alternative AED/CPR Presentation – Martha Mitchell

- Martha shared the history of ERTS (Emergency Response Team of Stone Crest)
- She shared the accomplishments of the team – Fact Sheets/Booklets were handed out
- Pat Gabriel asked what costs are involved
- 4 AED's - \$14.50 a piece → Correction, \$1,450
- Storage Cabinet - \$310
- Their budget is \$9K
- Several residents have donated \$75
- Yearly fee for pager \$20

B. Standby Presentation – Chief Nevels

- Shared the current guidelines of the standby policy
- Discussed current rates
- Pat Gabriel asked how long ago rates were approved? Five years per Chief Nevels
- Chief Nevels shared a draft of how standby events are structured
- Board moves to approve the draft for the BCC's approval

C. Other Business

- The 15 firefighter positions will not be in next fiscal year budget if necessary.
- The department can get by with replacing 2 pumpers instead of 3
- Engines are not refurbished after 10 years; however we replace chassis for the ambulances.
- Master Plan handed out
- Chief McElhanev suggested Chair(Pat Gabriel) attend budget review, July 15, 2010
- Draft up options about how the Fire Advisory Board move forward, to present to the BCC. Chief McElhanev suggests we get through budgets first, then discuss at the next Advisory Board Meeting, August 10, 2010
- Chief Dan Gentry suggested quarterly meetings
- Dr. Fraunfelter shared that in regards to CPR, Marion County is looking at statewide education
- Marion County is getting its Stemi/Cardiac patients in quicker – great coordination efforts between the hospitals and Fire Rescue


