WHEREAS, the SSCRA Trust Fund for Fiscal Year 2021-2022 is slated to receive a contribution from Marion County, Florida; and

WHEREAS, the Agency shall adopt by resolution a SSCRA Trust Fund fiscal year budget each year, pursuant to Section 189.016(3), F.S.; and

WHEREAS, the proposed Silver Springs Community Redevelopment Area Fiscal Year 2021-2022 Budget is attached hereto as Exhibit "A";

NOW THEREFORE, BE IT RESOLVED by the Marion County Community Redevelopment Agency Governing Board, Marion County, Florida, on this 14th Day of September, 2021, that the aforementioned Silver Springs CRA FY 2020-2021 Budget attached hereto as **Exhibit "A"** is hereby approved and adopted for inclusion in the Marion County Board of County Commissioners' Countywide Fiscal Year 2021-2022 Budget, pursuant to Section 189.016(5), F.S.
