This project will alleviate wait lists at the Ocala Domestic Violence Shelter by accepting referrals of families from the shelter into partner transitional housing units and rapid rehousing programs. Currently, because affordable housing is in short supply, families whose domestic violence crisis has been stabilized are remaining in the DV shelter for longer than otherwise necessary. The result is an overburdened domestic violence shelter that must turn families away.

The proposed program will offer an opportunity for families on the Coordinated Entry Priority List who have resolved their immediate domestic violence crisis to enter transitional housing or receive rapid rehousing services from one of the 3 project partners. Participants will receive trauma-informed, victim-centered services. The project will provide 3 transitional housing units (1 at each partner), as well as short to medium-term rapid rehousing assistance for an estimated 16 families. We have budgeted for 1 year of rental assistance for 4 families, but we believe that with intensive case management, many families will achieve independence more quickly, freeing up funds for additional families. Rapid rehousing will be into scattered site apartments with leases held by participants. Participants may choose rapid rehousing at any point, including at referral.

We anticipate that this project will serve 25 families (9 through transitional housing and an additional 16 through rapid rehousing) with 75 members. Families will have access to trauma-informed, victim-centered case management services designed to help them secure and maintain permanent housing. Case managers will work with them to develop individualized goal plans and either directly provide or connect them with resources including basic needs (food and clothing), transportation, assistance with applying for mainstream benefits, medical, dental, behavioral, and chemical healthcare, job training/employment, legal issues, and the educational rights and needs of both the participants and their minor children. The program has processes in place to comply with the Violence Against Women Act. Families will receive education and assistance in conducting a housing search and tenant rights and responsibilities and funds will be available for move-in expenses such as utility and damage deposits.

Partner agency staff are trained in providing trauma-informed, victim-centered services. The Domestic Violence Center will provide additional training on best practices for working with families who have experienced domestic violence. Families will also continue to receive specialized services related to domestic

violence through the Domestic Violence Center as needed. Once families secure permanent housing, they will have access to ongoing case management for up to the maximum allowable period to ensure that they remain safely and stably housed.


