INTRODUCTIONS:

- Beth explained the purpose of this meeting is for the chair of each group to give a brief update on what the groups have been working on.

Community Outreach and Education – Chair Lauren Debick:

- Speaker's bureau list will continue to grow as people are added.
- Create of list of organizations to speak at churches, HOA other community gatherings,
- Dedicate a week in schools for litter awareness.
- Focus on crime prevention (what litter can do).
- Create a Trash Mob (kinda like a Flash Mob).

Fiscal – Chair John Paglia III:

- Group to work on developing a baseline of numbers to compare in the end.
- Group word like to look at fund raising.

Chair Beth McCall:

• There is a lot of unknowns. To get this County where we need to go it may cost more money before we start seeing a savings.

Jody Kirkman - Environmental Services Director:

• Gave overview of Solid Waste and hours.

Marketing – Antoinette Davis:

- Group would like to move forward with slogan No Horsin Around.
- Mascot a horse name Marion and his side kick Rubbish the Raccoon.
- The group will continue to look for ideals on how to market our mascot and slogan.
- County will look to hire a marketing firm.

Ordinances and Enforcement – Bill Gladson:

- Group feels that we are not going to be able to enforce our way of the problem.
- Group has looked over several statics of enforcement that is occurred in the last year or two.
- Group has review the state statue vs the County ordinance.
- Group feels that the fine are not strong enough.

- To help with enforcement the County can take not sworn employees and designate them to help enforce the litter laws.
- Recommendations from the group:
- Bring back cover your load fees.
- Educate Law Enforcement on Litter Laws.
- Create a data base that is shared between agencies.
- Promote Adopt-A-Road.
- Look at Solid Waste Staffing.
- Create a shame game like Polk County.
- Create a free litter phone app.
- Statues work better then ordinances.
- Community Service buy out should start fading away.
