## RESOLTUION NO. 80-R- 257

## A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA

WHEREAS, the Board of County Commissioners of Marion County, Florida, held a Special Election in Silver Springs Shores on <u>March</u>, 11, 1980, for the purpose of voting for or against the establishment of a Municipal Service Taxing Unit for recreation, law enforcement and street lighting, for the residents of Silver Springs Shores; and,

WHEREAS, a majority of the electors voting in the above-mentioned election voted in favor of the establishment of a Municipal Service Taxing Unit for Silver Springs Shores; and,

WHEREAS, the Board of County Commissioners of Marion County, Florida, adopted Marion County Ordinance No. 80-9 on September 24, 1980, establishing the Silver Springs Shores Special Tax District; and,

WHEREAS, the Board of County Commissioners of Marion County, Florida, is authorized by paragraph 19 of subsection C of Section II of Marion County Ordinance 80-9 to provide for a Advisory Council and appoint its members; and,

WHEREAS, the Board of County Commissioners desires by means of this Resolution to provide for the Silver Springs Shores Special Tax District Advisory Council, and appoint its members.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Marion County, Florida, as follows:

- 1. That the Silver Springs Shores Special Tax District Advisory Council is hereby established.
- 2. That the following people are hereby appointed to serve as members on said Advisory Council for the terms set forth below:

- 3. That the Silver Springs Shores Special Tax District Advisory Council is hereby empowered to advise the Board of County Commissioners of Marion County, Florida, on matters concerning the Silvers Springs Shores Special Tax District Advisory Council.
- 4. This Resolution shall be made a part of the Public Records of Marion County, Florida, at its meeting of the Board of County Commissioners of Marion County, Florida, and a copy of this Resolution will be furnished to each member of the Silver Springs Shores Special Tax District.
