

RESOLUTION 10-R-630

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA, PROVIDING VARIOUS FEES AND CHARGES, PROVIDING A WAIVER FOR INDIGENT PERSONS, PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Board has authority to adopt fees and charge for various services provided by County Departments and the Board desires to reorganize and clarify said fees and charges, now therefore,

**BE IT RESOLVED** by the Board of County Commissioners of Marion County, Florida:

**SECTION 1. Fee Schedule.** The Board hereby reorganizes and clarifies said fees and charges to be collected by the Office of the County Engineer, to cover the cost of services, and that all fees collected will be placed in the Transportation Maintenance Fund, and adopts the fee schedule attached hereto as Exhibit A. With the adoption of this Resolution, all previous Resolutions are hereby superceded.

**SECTION 2. Waiver.** The Board hereby authorizes the waiver of the attached fees for other public agencies when the proposed project is in the best interest of the public, and for indigent persons upon submission of a letter of certification prepared by the Marion County Community Services Department to the Office of the County Engineer.

**SECTION 3. Effective Date.** This Resolution shall take effect immediately upon adoption.
