The September 28, 2023, meeting of the Rainbow Lakes Advisory Committee was called to order by Chairman Dallas Seveland. Other committee members present were Paula Gawlik, Gary Levit, Allen McKay, George Shaver, Katherine Bryant and Dan Wilshusen. Guests present were Matthew Leibfried, MSTU Director, MCSO Lt. Mongeluzzo and Matthew Cretul, Legislative Manager MCBCC. There were 16 people in attendance. The meeting was opened with invocation followed by the Pledge of Allegiance.

Agenda Item Public Comment (1):

Approval of Minutes (2A) April 21, 2022:

Motion made by Wilshusen, seconded by McKay to accept minutes July 20, 2023 (2A). Motion carried.

Committee Reports (3):

Building & Grounds: Bryant stated the outlets have been completed in the Rainbow Room. The lights were replaced in the Youth Center and two (2) lights added to the District Office. The air conditioning in the Creative Arts Center has been repaired. The Clubhouse is not in use and the ceiling needs to be repaired. William Watson is the new Maintenance Supervisor as of October 1, 2023. Levit asked how do we know about job positions. Leibfried responded are new project manager Katy Burton went to a Marion County job fair with flyers and information. We received potential candidates that was interested that are in this area. Also, it is advertised on the Marion County website. Code: Shaver stated one (1) issue about height of a fence. Reached out to Marion County Code three (3) days ago, haven't heard back

Levy County: Wilshusen reported we have a home that was vandalized while the owner was away on vacation. The home was spray painted with initials WDS. We also found a stop sign that had been spray painted. We still have four (4) open code enforcement violation cases. All have been reported to Levy County Code Enforcement. We have closed or cleared four (4) other cases. The street sign issue has been resolved at 124th and 125th. There is still a street sign out on SE 123rd that just seems to be in the wrong place. Some of the larger potholes at the beginning of SE 125th were filled in as well. Stop sign on 126th Terrace and 114th Pl. was ran over. Work order has been put in. Stated not sure if MCSO communicated the change with RLE Crime watch with LCSO as we haven't seen additional coverage as a result of loosing our Crime Watch patrols. Two (2) cruisers were spotted on SE 114th last week.

Public Safety: McKay reported for the month of August nineteen (19) urgent medical calls; two (2) life threating calls; two (2) urgent fire calls with a total of twenty-three (23) calls. McKay questioned if a tour of all RLE facilities been scheduled yet. Seveland responded no. Discussion followed. McKay reported that the existing bus stops at Trout, Marine Blvd, Ivy Pl, and Anchor Blvd. are in accordance with FDOT standards. These stops will remain as they are. If parents have concerns they can contact their child's school and request a change of stop. Joseph Wain, Levy County Coordinator of Transportation stated "It was determined that we are using these roads to service the students that in this area and we are unable to avoid them." Concerning SE 100th Pl. bus routes.

Recreation: Gawlik reviewed upcoming events and RLE Club meetings. Stated volunteers are needed for the Youth Center activities. If interested call 352-489-4280 a level 1 background check is required, paid for by RLE. Gawlik stated that she noticed that in the Riverland Levy County: Wilshusen reported we have a home that was vandalized while the owner was away on vacation. The home was spray

Levit reported to the post office about mail being dumped on Four Oaks and Peach Blossom. Post office sent someone out to retrieve mail.

Committees/Guests (4):

Lt. Mongeluzzo MCSO, stated we are working with some issues at Sea Cliff Park with spray painting profanity and body parts. Detectives put up cameras to see if we can catch them. We need to work on "If you see something say something." Regarding the mail we can write a report and send it to the post office. We have to be involved. Digital speed limit sign has been put up that has other special features other than radar. October 31st is our annual candy sweep. You will see more patrols out and some under cover vehicle's and checking sex offenders in the area. There was a deputy involved shooting on Highway 41. Deputies are ok and the individual is ok and was released from the bospital. Deputy will back at work soon. Concerning the Crime Watch all but (2) two members have quit in RLF. We have ground from the hospital. Deputy will back at work soon. Concerning the Crime Watch all but (2) two members have quit in RLE. We have grouped them into the Dunnellon COPS' program. Discussion followed.

Matthew Leibfried, MSTU Director, stated the clean up along the truck route road that the OCE has cleaned up some trees along the side of the road and is partnering up with RLE Supervisor to continuing working together.

Matthew Cretul, Legislative Manager MCBCC introduced himself. Will continue discussion in new business items. See (7C.) Consent (5): None

Old Business (6):

Levy County Ordinance 2022-21 (6A) - Wilshusen stated he heard back from Stacey Hectus, Levy County Planning and Zoning Director. The ordinance will go before the Levy County Board of Commission on October 17th at their 9am meeting. Then presented on November 7th at 5pm. Discussion followed. Wilshusen reported the current existing homes onsite has to be grandfather in and has to meet Florida building codes.

RL Blvd Median (6B)- Leibfried stated that he spoke with OCE about the medians. They do not absorb or divert water. They're solely for

aesthetics. It's up to the board where to go further. Seveland questioned if there's going to be landscaping done. Spicuzza responded it's in the new budget. Discussion followed. Seveland suggested to remove and strip them replace with painted lines and reflectors. Leibfried responded would need drawing plans, designs plans, and set money aside for budget. Leibfried opinion is RLE has a lot of driveway up and down this road way from all the way down from highway 41 down to Community Center Complex. For long term future down the road consider two-way road with six-foot road bike path or walking path that would run from entrance to the Community Center Complex. Leibfried to provide info at next meeting. Seveland stated do you need a vote for that? Leibfried responded yes. Seveland asked does someone want to vote for an estimate for repaving the medians. Motion made by Shaver, seconded by Wilshusen to get pricing for repaving the medians. Motion carried.

George Pugliese Field at Sea Cliff Community Park (6C) - Seveland questioned what progress has been made with renaming the baseball field at Sea Cliff Park in honor of George Pugliese a resident and dedicated community volunteer. Spicuzza responded the sign has not been received yet. Discussion followed. Seveland stated we looking around Spring time. Discussion followed.

New signage parks & Community Center Complex (6D) - Seveland the board voted to rename two (2) parks and the Community Center area. Questioned if new signs had been ordered. Spicuzza responded signs will not be ordered until new budget starts Monday.

New Business/Board Items (7):

Crime Watch (7A) - McKay stated RLE Crime Watch per Sheriff's Department orders cannot patrol Levy County roads any longer. Crime Watch held a meeting September 6th where Robert Ethridge, MCSO volunteer Coordinator told the group officially of the Sheriff's directive. The group was pooled and of the nine (9), five (5) stated their intention to no longer associate themselves with Crime Watch. Since that meeting all but two (2) people have expressed their intention to resign. McKay stated he has been asked to address the board about this issue and the boards help and approval for the possibility of taking over this function to enable us to provided Levy County RLE residents the same level of service afforded Marion County RLE residents. McKay asked the board if we could purchase a car from the county for RLE Crime Watch use and maintain and insure it ourselves. Spoke with Lt. Bloom on this issue and while the Sheriff's addict is firm we can form our own group. We would need to purchase a vehicle and not identify ourselves as representing MCSO. Seveland stated it appears that MCSO has decided to renege on a decades old agreement whereas Crime Watch has patrolled the small portion of Levy County that falls into RLE MSD. This action has caused the majority of members to suspend themselves from service, leaving only two (2) active members. Based on this MCSO has now decided to dissolve Crime Watch in RLE together and remove the vehicle from our district. Crime Watch is vital part of our community and due to these actions by MCSO we are now left with no patrols or vehicle's. I believe as a board we have two (2) options. First, request that MCSO reinstate full coverage to RLE including honoring the agreement to patrol the small Levy portion. Secondly, If MCSO refuses to do so then I believe we as a board need to create our own independent crime watch which would include the donation or purchase of a vehicle for patrols. Oversight of an independent crime watch would fall under the supervision of this board. Personally, I feel this action by MCSO is reprehensible and puts our entire district at risk. Discussion followed. Wilshusen reported he would like to propose that we as a board recommend and establish our own RLE Enforcement Department. I see this as a department that would oversee our own volunteer Crime Watch staffed by RLE volunteers, as well as our code enforcement staff. I think that we can do this with one full time person to oversee these two areas. We would also need one (1) or two (2) code enforcement members to do field work and site visits. We would need (2) two vehicles one for crime watch and one for code enforcement. It could increase taxes approximately fifteen dollars (\$15) per parcel. This amount is an estimate and could vary depending on the size of the program. Discussion followed.

Station II usage (7B) - Seveland stated that MCFR would be relinquishing use of RLEVFD Station II returning back to community. Would like to hear from the board on suggestions and ideas for use of the building. Want to hear from RLE Recreation Leader Robert Howard. This item will be on November 16th agenda. Robert Howard be in attendance.

Broadband (7C) - Matthew Cretul, Legislative Manager MCBCC, stated multiple service providers have been awarded grants for expanding their services within RLE through both state & federal programs. You can find more about the award area (and check specific addresses) experience arcgis.com. Regarding the state awards, internet service providers are still working with Florida's Office of Broadband through the challenge and contract processes. Once both are complete, the service providers can generate a timeline of when the buildout might begin. The service providers working on Federal grants have begun buildouts in award area near RLE but are still struggling with the after effects of supply chain issues. Once the providers have a realistic timeline for their buildout in RLE, they will pass it along to the residents. I'm always available if residents have any questions. matthew.cretul@marion.org

I think that we can do this with one full time person to oversee these two areas and provide the clerical support to file and process the required paperwork and reports to maintain regulatory compliance. We would also need 1 or 2 code enforcement members to do field work and site visits.

I think we need to open a discussion with our Marion support members to assist us with guidance for requirements and direction in making this happen. - 3. The board was supposed to tour ALL RLE facilities. Has this been scheduled? It is vital and incumbent of ALL board members to be familiar with our buildings and facilities and their safety, condition and functionality. I would like to ask that it be done as soon as possible prior to the next meeting.

Additionally, a great deal of discussion and background information is NOT recorded in the minutes sent to and posted by the county. This discussion is vital to not only the function of the board but to our residents as well. I do note that the most recent minutes are more complete but not all points are covered. Residents should be able to access either a recording of the entire meeting or a verbatim transcription of it. (I will later make a motion that this be done). I would allow my recording to be used if this is legal and the board agrees. As to the mechanics of it, I believe that is a county function which we already pay for.
- 5. Bus Stops I have received an answer from Marion County Transportation. The existing stops at Trout and Marine and Ivy and Anchor are in accordance with FDOT standards and have been in place for many years. They have students on both sides of Marine going to that stop and likewise on Ivy. These stops will remain as they are. If parents have concerns they can call their child's school and request a change of stop. There is a stop on Four Oaks and Honeysuckle that may or may not change that they could go to. In any event parents need to call their school and they can initiate the change for them.
- 6. Per communication from Levy County Coordinator of Transportation, Joseph Wain regarding SE 100 Place bus routes "it was determined that we are using these roads to service the students that live in this area and we are unable to avoid them".

This item will be addressed when the Crime Watch agenda Item is brought up.


Crime Watch - Mr Chairman, It is my sad duty to report that RLE Crime Watch per Sheriff's Dept orders cannot patrol Levy County roads any longer. There had been a permission dating to 1999 from then Sheriff Ed Dean to then Crime Watch Group President Floyd Potter (attached) allowing this and successive Sheriff's had no issue with it. Apparently, Sheriff Woods is not in agreement and even though this letter was run up the chain of command at MCSO they will not permit the county car to cross the county border.

Crime Watch held a meeting on 9-6 where Robert Ethridge, MCSO Volunteer Coordinator told the group officially of the Sheriff's directive. The group was polled and of the 9 there 5 stated their intention to no longer associate themselves with Crime Watch. Further since that meeting all but 2 people have expressed their intention to resign. The remaining 2 people, while dedicated and willing to help our community cannot adequately patrol the many miles of our roads.

I have been asked to address the board about this issue. I ask for the board's help and approval for the possibility of taking over this function to enable us to provide Levy County RLE residents the same level of service afforded Marion County RLE residents.

In light of this situation I would ask the board if we could and/or should purchase a car from the county for RLE Crime Watch use and maintain and insure it ourselves. This appears to be the only way we can continue to give Levy County residents the service they deserve.

I have spoken with Lt Bloom on this issue and while the Sheriff's edict is firm we can form our own group. We would need to purchase a vehicle (Weeks Auction Ocala) and not identify ourselves as representing MCSO. I told him the situation of only 2 people remaining and he said they will disband the RLE Crime Watch and roll the remaining 2 people into Dunnellon COPS.
