A RESOLUTION TO ESTABLISH NEW AMBULANCE RATES IN MARION COUNTY AND PROVIDING AN EFFECTIVE DATE

WHEREAS, Chapter 155.22, Florida Statutes, authorizes the various Boards of County Commissioners in the state to establish a county ambulance service; and,

WHEREAS, the Board of County Commissioners of Marion County, Florida has seen fit to establish such an ambulance service and has assigned this responsibility to Marion County Fire Rescue (MCFR); and,

WHEREAS, MCFR has been providing ambulance service to the citizens of Marion County, Florida since October 1, 2008; and,

WHEREAS, MCFR conducted a state-wide survey and determined the current rate charges are not competitive with similar agencies; and,

WHEREAS, MCFR has presented to the Board of County Commissioners of Marion County, Florida proposed rate charges to help further offset the taxpayer expenses of operating said ambulance service; and,

WHEREAS, the Board of County Commissioners of Marion County, Florida desires to adopt the proposed rates in order to provide further relief to taxpayers by shifting more of the costs to users of the service while continuing to provide effective ambulance service and to maintain that capability,

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Marion County, Florida, as follows:

SECTION 1. RATES. That the below described ambulance rates are hereby adopted and made effective.
